1 Certification Conditions

1.1 Introduction

The Client shall comply with the following conditions governing the use of the Certificate of Quality Approval and mark/symbol of the Certification Body.

1.2 Use of Certificate of Quality Approval

- (a) The certificate shall remain the property of the Certification Body.
- (b) Certificates are valid for three years from the date of the certificate issue, subject to satisfactory annual surveillance assessments.
- (c) Certificates are not transferable.
- (d) The certificate shall only be displayed at the location applicable to the certificated scope of supply.
- (e) The certificate shall not be used to imply certification of any location other than that detailed on the certificate.
- (f) The certificate shall not be used in any way to imply product approval.
- (g) The certificated client must advise the Certification Body of any changes which may affect the scope of supply.
- (h) The certified client shall inform the certification body, without delay, of matters that may affect the capability of the management system to continue to fulfil the requirements of the standard used for certification. These include, for example, changes relating to
 - a) the legal, commercial, organizational status or ownership,
 - b) organization and management (e.g. key managerial, decision-making or technical staff),
 - c) contact address and sites,
 - d) scope of operations under the certified management system, and
 - e) major changes to the management system and processes.
- (i) If the Client changes operating site then the certification body shall conduct a surveillance visit to check the Management System is operating to the requirements of ISO 9001:2015 & AS 9100D:2016.
- (j) In the case of AQMS audits, MTIC shall inform the other party that the report is available in the OASIS database.
- (k) AQMS-certified organizations shall allow MTIC to provide Tier 1 and Tier 2 data to the OASIS database.
- (l) Organizations shall provide access to the data in the OASIS database to customers/authorities unless a justification is provided.
- (m) If an organization loses its AQMS standard certificate, it shall provide immediate justification to the customers.
- (n) Organizations shall identify an OASIS administrator and be responsible for notifying the certification body of significant changes in the organization.
- (o) Failure to comply with the above shall result in withdrawal from both the ICOP scheme and the OASIS database.

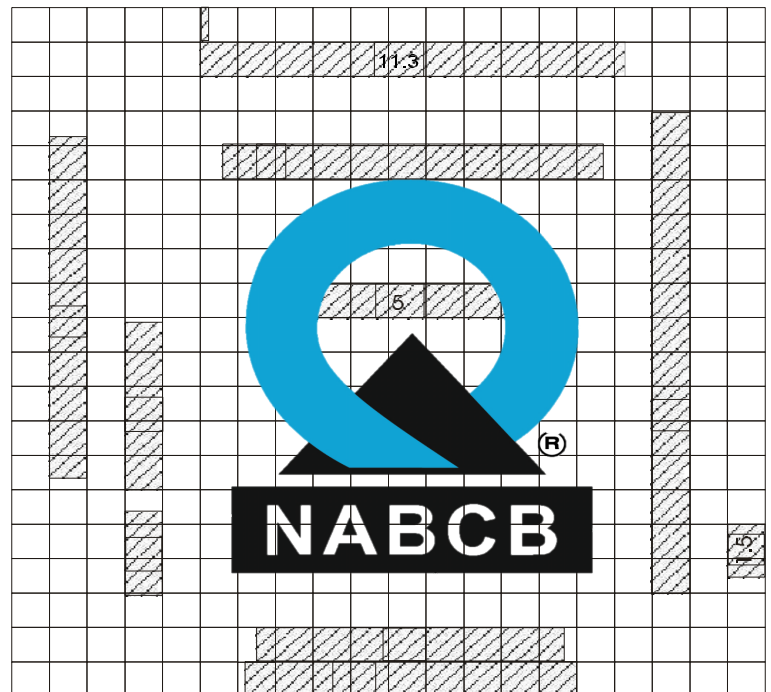
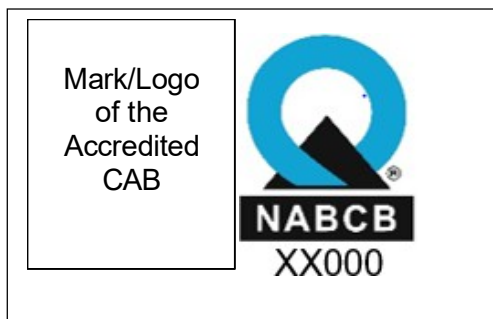

- Upon termination of the certification accreditation on account of non-renewal/withdrawal of the certification certified body shall immediately cease to use its stationery and other publicity material that has certification logo on them.

- In the case of marks or logos misuse, by a CB accredited by an SMS approved AB, the AB shall take appropriate action up to and including suspension or withdrawal of the CB.

1.4 Use of the MTIC InterCert India Private Limited Symbol



- (a) The symbol shall be used in conjunction with the NABCB logo
- (b) The symbol shall always be used in conjunction with the Client's name.
- (c) The symbol shall be used on stationery, such as headed letter paper, advertising brochures, and only in connection with the International Quality System Standard and scope of supply listed on the Certificate.
- (d) The symbol Shall not be used on Visiting Cards, test certificates, Confirmity of the product, vehicles, buildings or flags which bear the name or emblem of the Client.
- (e) The symbol shall not be used in any way to imply product approval.
- (f) The certified Client shall, upon reasonable notice, discontinue any use of the symbol which is considered to be unacceptable to the Certification Body.
- (g) Upon termination of the certification, for whatever reason, the Client shall discontinue all use of the symbol immediately.

1.5 Failure to Comply with the Certification Conditions

Suspension and withdrawal of certificate approval

If the Client/certificate holder fails to maintain compliance with the requirements of certified standard such as ISO 9001, those requirements detailed in Certification Conditions Document form P 08/04 and those commercial and operating requirements of the certification body then;

- The client/certificate holder is formally informed in writing/fax/phone/email about the failure of compliance to the above conditions and asked to detail corrective action.
- If the client refuses to respond to correct the failure of non-compliance to the above conditions then the Scheme manager shall contact the client and inform the client that the certificate may be suspended initially for 6 months and after 6 months the client is informed that the certificate is cancelled and would the client return the certificates and cease to use and distribute any literature, stationary, etc., referencing the certificate of Certification Body mark/symbol.
- If the period of surveillance exceeds the contracted period 6m or the recertification period exceeded the three year period the rules of suspension also apply.

Special Audits

- **Extension to scope** – MTIC shall review the application for extension to the scope of certification in **situation's like Addition of one or more sites, Increase of production of product other than under certified scope, Addition of design activity** and shall determine the need of any audit activities. Depending on the complexity of there change this may require a special visit or may be conducted in conjunction with a surveillance audit.
- **Reduction of scope of certification** – MTIC shall review the extent of reduction of scope of certification either on client information or during on-site surveillance **situation's like closure of one or more sites, Stoppage of production of product other than under certified scope, Stoppage of design activity** and the Scheme Manager will determine the need of any audit activities. MTIC shall contact the client and ask him to return the certificate and then re-issue a certificate with the reduced scope.
- **Short-notice audits** – MTIC reserve the right to conduct short notice audits on certified clients to investigate complaints, in response to changes or as follow up on suspended clients.
